7.5 Justice Re-investment - Bipartisan approach needed.

1. That the Northern Synod, in conjunction with the Synod of Western Australia, raises the issue of the over representation of Aboriginal young people in prisons with relevant government departments. We request that Western Australian, Northern Territory and Federal Governments actively pursue alternative measures to change the outcomes for young Aboriginal people and invest in Indigenous solutions.

2. That the Northern Synod forms a working group to advocate and support the pursuit of Juvenile justice.

Rationale

We are locking up Aboriginal children as young as 10 years old. 6% of the population but 58% of 10-17 year olds in detention. Australia has had a long and punitive approach to removing Indigenous children from their families and communities.

Given the gross over representation of First people in prison and the escalating costs, we request that Government adopts a process of Justice re-investment of investing a proportion of this cost back into Aboriginal Communities for early education, training and employment.

In WA Indigenous people are jailed at a rate 18 times that of non-Aboriginal Western Australian adults, but the overall rate is high too. The great costs of this punitive approach yield few clear benefits.

It costs around \$652 a day to lock up a young person in detention. It costs a lot less to educate and if required, rehabilitate a young person.

Simply put, Justice Reinvestment takes money out of prisons and puts it back into communities where juvenile crime is occurring. It's a smarter, cost-effective approach to criminal justice.

Just as the UCA led the nation in changing the Preamble to our Constitution so must we lead the way in changing our justice system.

9. FAREWELL AND MEMORIAL MINUTES

9.1 Memorial Minute for Joy Morlumbun

Joy was an Elder from the Mowanjum community in West Kimberley. She was a Worrorra woman with a passion for her language and culture. She was born in the 1950's at old Mowanjum Mission near Derby and grew up there. As the young son of the Presbyterian minister at the time, Andrew Watts got to know Joy and the Morlumbun kids in the late 1960s when they would occasionally be over at the Watts' house at Old Mowanjum.

When returning to West Kimberley as a Uniting Church minister in 2000's, Andrew recalls Joy's delight in watching his children grow and change and chatting with them when she saw them. For Andrew, this was just a glimpse of the love Joy had for her own family. She particularly enjoyed the children, talking with them, having them stay with her, and celebrating their milestones and achievements. Joy always worked hard to support her family, and encourage them in their endeavours.

Joy went through some very tough times as a younger person but it is a tribute to her own personal strength, her faith in God, and the support of family and friends that she found a way through those difficulties.

One thing Joy came to be known for was her tremendous passion. She was passionate about the traditions and paths laid out by the Mowanjum elders of the past for the people of today. She was passionate about the Worrorra language, that it be spoken with the right accent and even be spelt in certain ways, reflecting some of the spelling of the old days at Kunmunya. She was passionate about Mowanjum, its past, present and future. In her later life, she had a longing to return to the early mission site at Kunmunya. She also wanted to see a memorial constructed at the site that recognised its existence.

Over time, Joy developed a good understanding and knowledge of many of the systems that frustrated everyday life for people at Mowanjum and in Derby. It was no surprise, then, that many people would turn to her for advice and assistance and that she played many roles in various community organisations and on various committees and councils. She was a regular attender at NRCC and Synod meetings and also Co-ordinate meetings.

Through all the challenges that she faced, she maintained an ongoing love for Jesus and God. Her faith was deep and she had a hunger for learning more. This meant she undertook some studies at Nungalinya College and enjoyed discovering new insights in her personal reflections on bible readings, hymns, songs and commentaries throughout her life. She had a tremendous loyalty to the church. One reason for this was the church's role with the Worrorra since the Mission days of Port George IV and Kunmunya. Therefore she was delighted to be so involved in the planning and leading of the Mission centenary weekend held at Mowanjum in May 2013.

Joy was in hospital in Perth for some months in 2014 but returned to Mowanjum in November. She was able to see her family, but passed away soon after her return. It was a blessing that Joy returned home before her death. Joy's funeral service was held on December 5th 2014 in Mowanjum.

9.2 Memorial Minute: Rev Peter Nyaningu

lipuruku 12:1 Ka tjana kuwari nganananya ngarala nyanganyi winkingku Godaku

mulamularingkupai miri tju<u>t</u>anku

Hebrews 12:1 Since we are surrounded by so great a cloud of witnesses

This man was a great witness to Jesus, the pioneer and perfector of our faith. He lived his life spanning across 84 years in the APY Lands – beginning at the Ernabella Mission but travelling across this nation. His was an extraordinary life. In the words of Psalm 5:11 ... 'Surely Lord, you bless the righteous, you surround them with your favour as with a shield.'

He was born in the bush, his parents having migrated from the west to the Ernabella Mission, but he was educated in two cultures, was baptised and later ordained as an elder in the Presbyterian Mission church. He married, and established a family and worked as 'Cookie' for the community. But blessed with a desire to learn more, he travelled with his family to Nungalinya College in Darwin. At the age of 53, he was ordained a Minister of the Word in the Uniting Church – the first and only Pitjantjatjara speaking man and since retirement, became the National Elder for Central Australia in the Uniting Aboriginal and Islander Christian Congress (UAICC).

This joyful strong and constant witness carried his Bible wherever he went, across the APY Lands, to Alice, Darwin, Sydney, to his Nguratjara Homeland, or from the shed in Hidden Valley, the local Aged Care facility, and recently to his 'office' – the table in front of the Ernabella Church building. In his last years, how often did he seek to speak from the Book of Romans, with a great desire to learn and bring Paul's message to his people. With his passing, it is the end of an era.

Stuart McMillan - Moderator Northern Synod, Uniting Church in Australia writes: 'The deep and reflective wisdom our brother shared with the APY Land communities, the Northern Regional Christian Congress (NRCC) and the church more widely, will be greatly missed.'

Steve *Orme*, the NRCC Resource Worker noted that he was a "wise minister and passionate teacher of the Bible."

Bäpa Rronan, the national Chairperson of the UAICC, spoke of this Elder's "generosity of spirit, confidence of speech, sense of humour and grace that touched many people. We give thanks to God for this National Elder's life and his service to Christ and the Church through his teaching, wisdom and passionate leadership. We pray for his family."

In latter years, beginning in 1997, he became a lecturer with the Adelaide University's Centre for Aboriginal Studies in Music (CASM). He received a national award for his significant contribution to indigenous peoples through education and community work. Being an elder, traditional land owner and song owner, and an influential member within the Pitjantjatjara community, he taught traditional stories, songs and dances at CASM, and also shared his vast knowledge of traditional beliefs and practices. He tirelessly supported the teaching of traditional knowledge and performance in CASM over many years, both through his leadership and teaching in the University, and also in the Lands, where he facilitated the annual CASM 'inma' program.

A CASM spokesperson has written: "CASM students and staff also had the great honour of visiting his homeland at Ngaratjara, the heartland of the ngintaka (perentie) story and song line in the APY Lands. He was greatly loved in his special role at CASM, and was known affectionately as CASM 'tjamu' (grandfather). He was a true inspiration to both students and staff alike."

Amongst his special possessions, he carried a short biography of a friend and mentor Rev Lazarus Lamilami, from Warruwi (Goulburn Island) who was the first Aboriginal Methodist minister and ordained in 1966. In this biography, words quoted in memory of Lazarus which were written by Bernie Clarke in 1977, could also apply to the first ordained Pitjantjatjara minister:

'His lasting legacy was that he sought understanding and reconciliation between cultures, so he sought to understand the Gospel as an Aboriginal Man. He understood the challenge of the Gospel was to follow in Christ's footsteps. He knew this was a narrow path, but he also knew that not all signposts were in English.... As he found other signposts drawn from his heritage and culture he tried to share them, that the way might be clearer for us all.'

Thanks be to God for the great cloud of witnesses that surround us! Uwa mulapa!

9.3 Retirement Minute: Rev Teubiti Tapera

Teubiti was born in what is now the Republic of Kiribati in the Central Pacific Ocean. He moved to the Solomon Islands where he was received as a candidate for ministry within the United Church of Papua New Guinea and the Solomon Islands.

He trained at Rarongo Theological College, graduating in 1974. He was ordained and ministered for the next 13 years in the Solomon Islands. In 1988, he did further study at Nungalinya College before returning to the United Church as the Superintendent Minister in Rarongo Circuit in New Britain.

In 1991, he came to work with NRCC in the then Parish of Malakutjkutj covering Croker and Goulburn Islands. It was a two year secondment from the United Church. His stay was extended for another two years while he continued to minister at Warruwi. In 1995, he was issued with a call to remain as Minister with the Parish for another five years, living at Warruwi on Goulburn Island and was sponsored by the Uniting Church for permanent residency in Australia.

In 1997, he moved to Minjilang community on Croker Island and commenced part time work with the community to supplement his now part—time stipend. In 2000, the placement became non-stipended and Teubiti supported himself and his family working in the community while continuing to provide ministry to the congregation. He has worked in the community since that time and remained as Minister with the Minjilang congregation. He has been an active member of NRCC and the Northern Synod involved in meetings and committees including being a member of the National Assembly.

After over 20 years of ministry with NRCC, Teubiti applied to be received as a Minister of the Word in the Uniting Church in Australia. In November, 2014 he was admitted to the Uniting Church of Australia. At the time, he was receiving treatment in Adelaide for a serious illness. On returning to Darwin for recovery, he decided it was time to retire and did so in February this year. He continues to live at Minjilang with his wife, Emery and minister with the congregation.

A Service of Recognition of a Minister from another Denomination was held on the Sunday night of Synod. This was an opportunity for the Synod and NRCC to express their deep appreciation of the many years of faithful and dedicated service by Teubiti.
